RESOLUTION

The following Resolution was offered in MOTION by Jacob Dickson, who moved for its adoption, and seconded by Chad Gielen at the meeting of the members of the Louisiana Board of Drug and Device Distributors held on Thursday, May 6, 2021.

WHEREAS, Mr. Robert "Bob" Broadus was appointed by the governor of the state of Louisiana, Charles "Buddy" Roemer, on December 9, 1988 to serve as a member of the newly created Louisiana Board of Wholesale Drug Distributors; and

WHEREAS, Bob Broadus was elected Vice-Chairman of the Louisiana Board of Wholesale Drug Distributors serving from August 17, 1994 through November 7, 1996; and

WHEREAS, Bob Broadus was then elected Chairman of the Louisiana Board of Wholesale Drug Distributors (nka the Louisiana Board of Drug and Device Distributors as of 2015) serving from November 8, 1996 through April 6, 2021; and

WHEREAS, Bob Broadus unexpectedly passed away after a short illness on April 6, 2021; and

WHEREAS, this Board resolution shall take effect immediately.

THEREFORE, BE IT RESOLVED that the remaining current seated members of the Louisiana Board of Drug and Device Distributors wish to posthumously recognize Bob Broadus for his thirty-three (33) years of dedicated service as a member of and long-seated Chairman of the Louisiana Board of Drug and Device Distributors (fka the Louisiana Board of Wholesale Drug Distributors); and

BE IT FURTHER RESOLVED, recognition of the strong commitment of Bob Broadus over his years of service in safeguarding life and health and promoting the public welfare of the citizens of the state of Louisiana; and

BE IT ALSO FURTHER RESOLVED, that this Resolution shall serve as a memorial to Robert "Bob" Broadus, late Board member and Chairman of the Louisiana Board of Drug and Device Distributors.
